### H.E. Hakan Jevrell, Ambassador of Sweden to Singapore and Brunei Darussalam



Ambassador Håkan Jevrell was appointed Ambassador of Sweden to Singapore in August 2013 and also currently serves as the non-resident Ambassador of Sweden to Brunei Darussalam.

Mr Jevrell was State Secretary at the Swedish Ministry of Defense from 2007-2012. He was also the Political Adviser at the Swedish Prime Minister's office between 2006-2007.

Prior to his career in the Swedish government, Mr Jevrell was a Prosecutor at Västerorts Local Public Prosecution Office in Stockholm. Before he was a prosecutor, he was an Assistant Lawyer at Legio Advokatfirma, Stockholm and his legal career first began as a Law Clerk at County Administrative Court, Mariestad.

Mr Jevrell holds Masters of Law from Stockholm University and has also completed an Executive Management Program at the Institute for Leadership at Stockholm School of Economics.

Mr Jevrell has served as a Board Member for the Reserve Officers Organization in Stockholm and was also a Member of the Senior Advisory Board at Business Risk Management Europe Ltd (BRM), Stockholm.

### H.E. Lynn McDonald, Canadian High Commissioner to Singapore



Originally from Vancouver, British Columbia, Ms. McDonald is a graduate of the United World College of the Atlantic in the United Kingdom (IB, 1987) as well as of the University of Toronto's Trinity College (BA High Distinction, International Relations & Economics, 1991) and Faculty of Law (LLB, 1994). She was called to the Bar of British Columbia in 1995 and joined Canada's Department of Foreign Affairs and International Trade (DFAIT) in 1996.

During her time in Ottawa, Ms. McDonald worked in the Legal Bureau, the Trade Law Bureau, and the Trade Policy Bureau of DFAIT. In her most recent assignment at DFAIT headquarters, she served as the Director of the Intellectual Property Trade Policy Division (TMI) where she oversaw the negotiation of the intellectual property provisions of Canada's bilateral and multilateral trade agreements (2011-2014). Her positions overseas have

included serving as a legal advisor at the Permanent Mission of Canada to the World Trade Organization in Geneva, Switzerland (1999-2002) and also as Counsellor and Head of the trade policy section at the Embassy of Canada in Washington, D.C. (2005-2009). Her most recent assignment abroad was as Consul and Senior Trade Commissioner at the Consulate General of Canada in Hong Kong and Macao (2014-2016).

# Keynote Speaker and Panelist

Mr. Christopher Hodges, Professor of Justice Systems, Head of the Swiss Re/CMS Research Programme on Civil Justice Systems, Centre for Socio-Legal Studies, University of Oxford



Christopher Hodges is Professor of Justice Systems and a Supernumerary Fellow of Wolfson College, Oxford; Head of the Swiss Re/CMS Research Programme on Civil Justice Systems at the Centre for Socio-Legal Studies, University of Oxford; and a (non-practising) solicitor. He is a Board Member of the UK Research Integrity Office.

From 2013 to 2016 he was an Honorary Professor at China's leading law faculty at the China University of Political Science and Law, Beijing and Guest Professor at China's leading international law faculty, Wuhan University, Wuhan. From 2011-2014 he was Erasmus Professor of the Fundamentals of Private Law at Erasmus University, Rotterdam. In 2013 he was a Visiting Professor at Leuven University's Global Law School Programme and in 2014, a Visiting Fellow at the Australian National University, Canberra.

His research is directed at reviewing all EU regulatory and dispute resolution systems to devise an integrated and balanced civil justice and regulatory model for the European states. His books include "Law and Corporate Behaviour: Integrating Theories of Regulation and Enforcement" (Hart, 2015), "Consumer ADR in Europe" (Hart, 2012), "The Costs and Funding of Civil Litigation" (Hart, 2010), "The Reform of Class and Representative Actions in European Legal Systems: A New Approach to Collective Redress in Europe" (Hart, 2008), "European Regulation of Consumer Product Safety" (Oxford, 2005), "Multi-Party Actions" (Oxford, 2001), and "European Product Liability" (1993).

He graduated from New College, Oxford in 1976, obtained his PhD from King's College, London in 2003, and worked from 1977 to 2003 in various major law firms in the city of London, with a pan-EU practice. His advice has been sought after by the European Commission, European Parliament, numerous governments, as well as regulatory authorities, ombudsmen, multinational businesses and consumer associations across the world.

He also serves as co-coordinator of the pan-EU Civil Justice Systems Project, and the Stanford-Oxford Global Class Actions Project. Prof. Hodges also has a particular interest in health systems, and has chaired various committees in the sector, including the Pharmaceutical Services Negotiating Committee for England.

# Mr. Francesco Checchi, Anti-Corruption Adviser, Regional Office for Southeast Asia and the Pacific, UN Office on Drugs and Crime (UNODC)



Mr. Checchi has more than 12 years of experience working in international organizations in the area of good governance, public administration reform and anti-corruption. Currently Mr. Checchi serves as the UNODC Anti-Corruption Regional Adviser for South and Southeast Asia.

Mr. Checchi's work focuses on providing support to Member states of the UN Convention Against Corruption for implementation of the Convention; he provides expert advice and input to the development and implementation of technical assistance programmes in anti-corruption at the regional and/or national levels in Southeast Asia and South Asia, in accordance with the UNODC's overall strategy and as an integral element of the UNODC Regional Programme.

Main areas of Activity involving Mr. Checchi's expertise are: Developing anti-corruption policy and regulatory frameworks at national and sub-national levels; providing technical assistance to independent agencies and governmental units dealing with anti-corruption or responsible for promoting transparency and accountability, as well as, sound financial management in public services, development of integrity and disciplinary mechanisms in the line Ministries which include, development of anti-corruption legal frameworks and supporting criminal justice mechanisms to fight corruption.

Previously Mr. Checchi worked as Anti- Corruption Specialist at the UNDP covering Eastern Europe and Central Asia; he collaborated with several NGOs on democratic governance and human rights related issues. He holds a BA in Political Sciences of the University of Pisa (Italy) and a Master's Degree in Public Administration from the Sorbonne University.

# Ms. Tengku Ida Ismail, Vice-Chairman, International Chamber of Commerce - Malaysia; Executive Director, Legal and Secretarial, Nestlé Malaysia, Singapore & Brunei; Trustee, ASEAN CSR Network



Tengku Ida is the Executive Director, Legal & Secretarial of Nestlé Malaysia & Singapore, which is involved in the manufacturing, marketing, sales and distribution of well-known food and beverage products. She is an LL.B. (Hons) graduate of the University of Nottingham, U.K. and a Barrister-at-Law of Lincoln's Inn, with over 18 years of legal experience. Tengku Ida started her career as a litigation lawyer in a private legal practice before becoming an inhouse counsel of a Malaysian government linked company. In 2005, she joined the Legal & Secretarial Department of Nestlé Malaysia and she was seconded to the Nestlé Headquarters in Switzerland as Legal Counsel for Zone Asia, Oceania, Africa and Middle East for a few years before returning to Nestle Malaysia to head the Legal & Secretarial Department.

At Nestlé, the Company believes that in order to create long-term value for its shareholders, it must create value for the society it operates in as well. Subscribing to the view that corporate success and social welfare are interdependent, the Company focusses on three areas where the greatest potential for joint value creation with society, namely Nutrition, Water and Rural Development. These three areas are pivotal towards ensuring environmental sustainability and complying with regulatory law.

Nestle is also committed to conducting business with integrity, given its strong stance against corruption and bribery. This is seen in its roll-out of the Nestle Anti-Corruption, Gifts & Entertainment Guidelines in Malaysia, applying to its employees, third party suppliers and customers. An anonymous whistleblowing mechanism has been established for any person, whether within or without Nestle itself, to lodge complaints which will then be handled and investigated by an independent third party. She presently serves as Vice Chairman of the International Chamber of Commerce (Malaysia) ("ICC") and chairs the ICC Corporate Responsibility & Anti-Corruption Working Committee. She also serves as the Malaysian Trustee representative for the ASEAN CSR Network.

# Mr. Loh Yoon Min, Senior Assistant Director (Financial Investigations Branch), Corrupt Practices Investigation Bureau (CPIB)



Mr. Loh Yoon Min is a Senior Assistant Director (Financial Investigations Branch) in the Corrupt Practices Investigations Bureau (CPIB). He has been involved in law enforcement work for the past 30 years in various capacities with the Singapore Police Force, the Commercial Affairs Department and the CPIB.

Over that period, Mr. Loh has investigated or supervised investigations into numerous criminal offences involving complex commercial fraud and corruption. Mr. Loh is a member of the Institute of Chartered Accountants in England and Wales, holds an LLB (Hons) degree from the University of London and an LLM from the National University of Singapore.

In his present position with CPIB, Mr. Loh spearheads the Bureau's enforcement of money laundering offences under the provisions of the Corruption, Drug Trafficking and other Serious Crimes (Confiscation of Benefits) Act.

Born in Jakarta, February 1965, Pahala Nainggolan graduated from the State Accounting School (STAN) in 1992 and is qualified as an Indonesian Registered Accountant. He obtained his Master's degree in Financial Management in 2001 and received his Doctorate in Financial Management in 2009. Both were from the Faculty of Economics - University of Indonesia. His thesis and dissertation conducted comparative studies of taxation for listed companies in Indonesia as well as some Asian countries.
